**M**any professionals spend the majority of the work day sitting at their desk and the comfort of their office chair not only contributes to their quality of work, but also impacts their overall health. Individuals in wheelchairs spend ten or more hours a day sitting, and the impact of an uncustomized chair adversely affects their independence, movement, and quality of life. Children and young adults utilizing a wheelchair for mobility are in need of specialized customizations that will maximize their independence. The Positioning and Mobility Clinic generously sponsored by Rieke Office Interiors provides these specialized customizations for clients who are underinsured or uninsured. For children with neurological or other diagnoses causing physical disabilities that affect function, posture, positioning, skin integrity, and mobility, this clinic provides an opportunity for maximum independence and safety in the home and community.

For Amy Liss, the clinic has provided many benefits. Amy has spastic quadriplegic cerebral palsy

and has been receiving services from Easter Seals DuPage and the Fox Valley Region (ESDFVR) for the past 24 years, since she was five months old. "I have been driving without a license since I was 5 years old", says Liss. "Without a wheelchair that has been customized to my body, the curve in my spine would be much worse, affecting my health, including my breathing. The Positioning and Mobility Clinic has also helped me in my volunteer work at Easter Seals DuPage and the Fox Valley Region and Hill Crest Elementary School. And now that I am an employee of ESDFVR, my therapists have been able to work together to make sure that my positioning is optimum so that I am able to work on an adapted keyboard." Each year, around 160 clients, like Amy, benefit from the Positioning and Mobility Clinic.

Since 1952, Easter Seals DuPage and the Fox Valley Region has been serving children with a wide range of special

needs and their families. With locations in Villa Park, Naperville, and Elgin, Easter Seals DuPage and the Fox Valley Region is one of the largest and most highly regarded out-patient pediatric rehabilitation centers in the nation serving more than 3,000 infants, children, and young adults with developmental disabilities each year.

### Hockey Rules & Regulations:

- Team entry fee is \$600.00 (includes registration fee, food and beverage for players, and 10 general admission tickets). Proceeds go to Easter Seals DuPage & the Fox Valley Region and are tax deductible (Federal Tax ID #E9987-6434-05). General ticket admission is \$10.00.
- Please also select a sponsorship level of Bracket, Center Ice, Rink or Zamboni, to support Easter Seals DuPage & the Fox Valley Region.
- Team Roster and signed insurance waiver is required and must be returned by Monday, October 1 at 5:00PM.
- Registration is from 4:00PM - 4:45PM and all team members must report to the Team Registration Table by 4:45PM the day of the event.
- This is a single-elimination tournament.
- Each game is 12 minutes long with three, four-minute periods.
- Minimum of seven members to a team (6 on the ice at one time with one alternate). Each team must have at least two females playing at all times.
- All players must be employees of the company the Hockey Team is representing. Any falsification will result in disqualification and/or revocation of any winnings.
- We recommend safety equipment, long pants & high-top tennis shoes, which you will need to provide. **TENNIS SHOES REQUIRED.**

- Team is required to provide a team name. No foul or explicit concepts.
- There are no goalies. A zone near the goal will be designated the "no goalie zone."
- Points are only scored when the puck enters the net.
- Minor penalty is 10 full spins in the Penalty Box. Serious or repeated penalties will result in team member disqualification.
- All players must sign a Player Waiver.
- Penalties will be enforced and include: High sticking - lifting the stick off the ground; Hitching - grabbing hold of another player's chair; Tipping - willfully acting to tip another player over "Jungle Rules" or rough play.

### Hockey Team Spirit - Uniform Contest

**Team uniforms must adhere with the following guidelines:**

- Reflect team spirit, creativity & humor
- Use color or uniqueness to recognize your team members
- Cut shirts, use of foul language and explicit concepts are prohibited
- Wearing team shirts to the event is strongly recommended
